It has been verified that two of the brothers came to the United States and settled here. James in 1734 and John in 1740. Dr. Andrew Turnbull is believed to be a brother also settled in the United States.

Doctor Andrew Turnbull, born on December 2, 1720, in Scotland. Died March 13, 1792 in Charleston, South Carclina. Was married to Gracia Maria Rubina, daughter of a Greek merchant, at Smyrna Asiatic Turkey on August 22, 1753. Gracia was born july 13, 1736 and died August 2, 1798 in Charleston, South Carolina.

Doctor Andrew Turnbull, who, after Englands acquisition of Florida under the terms of the Peace of Paris in 1763, was granted 60,000 acres of land which later grew to 100,000 acres from the British Board of Trade. The plantation grant was established by Governor James Grant 18 miles south of now Daytona Beach, Florida and was called "New Smyrna" Plantation". Dr. Turnbull brought with him 1200 Greek, Italian and Minorcan colonists. On August 18, 1768 the colonists revolted and by 1778 the New Smyrna saga Turnbull and his wife Gracia settled in ended. Dr. Charleston, South Carolina where he became a successfull Physician

And quoting from E. P. Panagopoulas book NEW SMYRNA: "There were several accounts of the New Smyrna Colony. Most of them written during the era of Jacksonian liberalism, expressed a traditional version transmitted from generation to generation among the descendents of the New Smyrna colonists. They emphasized the sufferings of the original settlers and condemned Dr. Andrew Turnbull, the founder of the colony. The best of these accounts, despite the errors and omissions, offered valuable information; but even these were narrow in scope, dealing with only one aspect of the New Smyrna venture.

By far the most significant was the study by Carita Doggett Corse, DR. ANDREW TURNBULL AND THE NEW SMYRNA COLONY IN FLORIDA (FLORIDA 1919). This was the first book to emphasize the importance of the documents at the British Colonial Office for the appreciation of the New Smyrna Colony and, more than this, for an understanding of the personality and activities of its principal founder. The main purpose of this book was to erase the unsavory reputation created for Dr. Andrew Turnbull by almost all authors who wrote about New Smyrna; and Dr. Corse was the logical person to undertake this task, since she was a direct descendent of the remarkable doctor". Doctor Turnbull and Gracia had seven children, as follows:

- Nichol, born March 9, 1756, in Smyrna, Turkey, died 1836 at his place near Savvanah, Georgia, called "Deptford Hill". Married a widow, had one son named Nichol, who died unmarried.
- Jane, born April 28, 1760, in Smyrna, Turkey. Married (1) September 15, 1778 to a Mr. Marshall of Savannah, Georgia. (2) To a Mr. Holland. There were several children.
- Margaret, born November 4, 1761, in Smyrna, Turkey. Married (1) to a Mr. Holmes of Florida. (2) To E. M. Gray of Charleston, South Carolina. There were several children.
- 4. Maria Gracia, born January 21, 1766 in London England. Married Robert Harvey of Liverpool, England. Died April 2, 1814 in Liverpool, England.
- 5. William Duncan, born September 1770 in New Smyrna, Florida. Was educated, married and lived in England.
- 6. Robert James, bcrn January 14, 1773 in New Smyrna, Florida. Was educated in England, studied Law. Died June 14, 1833, buried in St. Phillips, in Charleston, South Carolina. Was married three times. Had one child by his first wife named Andrew, born in 1797.
- 7. John, born February 11, 1775 in New Smyrna, Florida. Educated in England. Lived in Charleston, Carolina. Married to Henriette Bolton Guerin. Several sons and one daughter to this marriage.

Another John Turnbull came to the United States from London, England in the last quarter of the 18th Century. He married Catherine Rucker of Virginia. He and his wife settled on Catalpa Plantation in West Feleciana Parish, Louisiana. They had four sons and three daughters. One of the sons; Daniel H. Turnbull married Martha Hilliard Barrow also of West Feleciana Parish. Daniel and his wife built a Georgian style, column mansion in 1835 with beautiful gardens surrounding it which at the present time, after restoration, is attracting thousands of visitors as a show place. It's location is near Saint Francisville, Louisiana and is called "Rosedown".

John Turnbull, younger brother of James Turnbull, arrived in the United States about 1740. First in the Delaware-Pennsylvania area and then he moved to Orange (now Augusta) County, Virginia and lived on Middle River near Churchville, where he was killed by indians on September 13, 1764. He was married to Mary Moffett. There was one son to this marriage: James Turnbull who was born February 25, 1753, died in Woodford County, Kentucky October 14, 1804. He was married (1) to Martha McNair. There was one caughter to this marriage named Hannah. Hannah married a Hugh Allen. James married (2) Jane Allen, born March 15,1755,died in March 1849. There were nine children to this marriage, as follows:

- 1. John, born November 9, 1780, died young.
- 2. Allen, born November 24, 1783; died February 3, 1790. Married twice; (1) Margaret McDowel in 1806; (2) Rachel Woodrow in 1811
- 3. William Allen, born April 4, 1786; died December 12, 1821.
- 4. James Allen, born February 5, 1788; died April 14, 1846. Married to Ann Shields.
- 5. Margaret Christian, born November 9, 1790. Married April 12, 1808 to James McCue. Lived in Augusta County, Virginia.
- Carry Allen, born November 24, 1792; died September 10, 1821.
- 7. Mary Louise, born September 15, 1795; died August 10, 1836 in Hillsborough, Ohio. Married December 10, 1813 to John M. Nelson.
- 8. Cyprus W., born December 30, 1797; died October 5, 1822.
- 9. John Allen, born May 31, 1801; died in 1885. Married November 5, 1829 to Levina Boys.

According to the "Complete Registry of the Turnbulls in America by Sharon Taylor" and published by Harbert's Inc., Bath, Ohio, 44210, in 1984". They claim 3000 households in the United States bear the name Turnbull, and over 8900 men women and children bear that name in the United States. In their publication they list over 2700 Turnbull households with name and address (and most with telephone numbers).

The text of the following pages represent the lineage between James Turnbull , who came to the United States in 1734, and those descendents bearing the name Turnbull.



To the left is the Coat-of-Arms used by James Turnbull (1734) and his lineage in the United States. JAMES TURNBULL was born in Bedrule, Scotland, near the border between old Scotland and England, now Great Britain, in the year 1710. His wife's name was Grace. They arrived in the United States in the year 1734.

From Lyman Chalkey records of Augusta, County, Virginia (Baltimore: Genealogical Publishing Company, reprint 1965), I, 308 and South Carolina Pre-Revolutionary Land Plats, State Archives, Columbia, South Carolina; James Turnbull arrived in Augusta County, Virginia as early as 1734.

After arriving in the United States he lived first in Orange (now Augusta) County, Virginia. In 1742 James served in Captain John Smith's Militia Company. On August 2, 1742, he bought 402 acres of land on Moffetts Creek from Benjamin Borden and operated a plantation on the land until he and his wife Grace sold it to Joseph Kennedy on August 2, 1754.

James and Grace then moved to Anson (now Mecklenburg) county, North Carolina. On August 12 1755, James applied for a grant of 192 acres on a branch of Rocky River, "a branch of Peedee River in South Carolina on the North Carolina line"; no grant was ever made by South Carolina. On February 24, 1756, he served in Captain Adam Alexander's Anson County Militia Company, and lived on Rocky river Through January 1763.

James and Grace Turnbull then moved to Granville (now Abbeville) County, South Carolina on February 1, 1763. James received a grant of 300 acres of land on the northwest fork of Long Cane Creek on August 27, 1764. James Turnbull "of Comonaire" died in 1766. On February 5, 1767, his son Joseph Turnbull of Long Cane was appointed administrator as next of kin. The personal property of the estate was evaluated by and the appraisers, Alexander McAlpin, Robert Caton Alexander Noble, on November 24, 1757. James Armstrong was appointed administrator about December, 1770, in the right wife (a daughter of James Turnbull) but Robert of his Turnbull (a son of James Turnbull) entered a plea to set aside the appointment. After the death of her husband, Grace Turnbull received a grant of 100 acres of land on Great Rocky Creek on August 20, 1767; she gave the land to her son Joseph Turnbull on December 1, 1770. The place and time of Graces death is unknown. James and Grace had seven children as follows:

 Robert, born in 1736; served along with his father in Captain Adam Alexander's militia in 1756; he also served under Colonel Richardson in the Cherokee expedition of 1759-60. Robert received certificates for 200 acres of land on February 5, 1765, and 100 acres land on May 11, 1769 on a branch of the northwest fork Long Creek. Time and place of his death and his marital status is unknown. He was still living there in 1787.

- 2. A daughter who was married to James Armstrong.
- 3. Joseph, born about 1740, died in 1808. He was first married to Elizabeth Crawford about 1769, she died about 1790. He then married Mrs Martha Bowles about 1799. There were nine children by his first wife and two by his second wife. Joseph died in Wilkes (now Greene) County, Georgia.
- 4. Issac, born in 1742, died in 1767, was unmarried.
- 5. JAMES TURNBULL, whose linkage is pertinent to this transcript will be discussed in the next paragraph.
- 6. Moses, born about 1754, died in 1828 in Newton County, Georgia. He married Catherine Lewis who was born about 1768 and died about 1845. After Moses moved to Georgia, in about 1784, he changed his name to Moses Trimble. The were seven children to this marriage.
- 7. John, born about 1756, died March 8, 1838 in DeCalb (now Fulton) County, Georgia. He married about 1781 Charity ?. There were six children to this marriage.

JAMES TURNBULL, son of James and Grace Turnbull was born in Augusta County, Virginia in 1744 and moved with his family until they finally settled in now Abbeville, South Carolina in 1763. About 1765 he married Esther McKinley, daughter of John and Esther McKinley. James received a certificate for 100 acres of land on the waters of Great Rocky Creek in Abbeville County on January 6, 1768, and for another 100 acres on the northwest fork of Long Creek on March 7,1769. James ' served South Carolina Militia after in the the in 1765 reduction of Charleston, and he received his payment for his services under Colonel Anderson. On January 4, 1767, James received a certificate for 18 acres near the-northeast fork of Long Cane Creek, and died there about 1788. His wife died there in 1818, The property was divided among the five children. Their children were as follows:

- James, born in 1766, died in 1796, was unmarried.
  JOHN, whose lineage is pertinent to this transcript will be discussed in the next paragraph.
- 3. Esther, born in 1770; married to Robert Smith. 4. Joseph, born in 1772; married to Mary St Mary Steadman, daughter of John Steadman and Jane Calhoun. There were three children to this marriage:
  - a. Eliza, born in 1796, married December 19, 1816 Thomas Thompson.
  - b. Robert.
  - c. James, married to ? Creswell.
- 5. Sarah, born 1775, married to ? Shannon.

JOHN TURNBULL, son of James and Esther Turnbull was born in 1768 in Abbeville County, South Carolina. John married Jane Steadman. Jane Steadman the granddaughter of James Calhoun

the emigrant, and Catherine Montgomery Calhoun. James and Catherine Calhoun were also the grand parents of John C. Calhoun who was prominent in South Carolina politics. John C. Calhoun was in the United States Congress in 1811, and Secretary of War in 1817. Aside from having been in the United States Senate he was Vice President of the United States from 1824 through 1832.

Calhoun was originally spelled Colquhoun. The Colquhouns left Scotland to escape religious persecutions and settled in Donegal, Ireland. In 1723 James Calhoun came to America and made his home in Lancaster County, Pennsylvania, where a few of the descendents are still living. In early 1760 four brothers and one sister; William, John, Ezekeil, Patrick and Catherine along with their mother, Catherine Montgomery Pennsylvania to Abbeville, South Calhoun, moved from Carolina and settled near each other about twelve miles west of the Abbeville Courthouse. For many years the settlement was called Calhoun Settlement. It is known today as Calhoun Falls. The mother, Catherine Montgomery Calhoun was massacred by indians with twenty two others at long cane in 1760, the same year she moved there

John Calhoun, one of the brothers who moved from Pennsylvania to Abbeville District South Carolina, in married Jane Ewing. Their children were John (the oldest), Mary, Jane and Rebecca. Jane married John Steadman. Their children were Mary, James, Jane and Sarah. Jane married the above mentioned John Turnbull. Joseph Turnbull married Mary, who was janes sister.

John Turnbull died December 13, 1820 and his wife Jane died 1833, both in Abbeville County, South Carolina. There in were nine children to this marriage:

- Floride, born in 1800; married March 20, 1817 to 1. Herbert Darracott. They had twelve children; John, Francis, William, Mary, Sarah, Thomas, Andrew, Louisa, Eliza, Theodore, Joseph and Martha.
- 2. Sarah, born in 1802, married to a Doctor Johnson. They had one child named Sarah.
- 3. Elijah E., born in 1805, married to Jane Young. They had six children:
  - a. Mary Elizabeth, she was married twice; (1) James Cook; (2) W. E. Turner.
  - b. Sarah, died in 1844.
  - c. Martha Ann, married to D. F. Dula.
  - d. Margaret Frances, married Tom Lovelace.
  - e. John.
  - f. Frances Young, born in 1841; died in 1846.
- 4. Jane, born in 1807, married Thomas J. Linton.
- 5. Nancy, born in 1809, married W. H. Kyle.
  6. JAMES THEODORE, whose lineage is pertinent to this transcript will be discussed in the next paragraph.

7. Mary Kempis, born in 1813; married to James Braddock Edwards. There were four boys to this, and three girls to this marriage.

8. Martha, born in 1815.

9. John Sheridan, born in Abbeyville County, South Carolina about 1818; married to Mary Prather. He was a carriage maker. There were five children to this marriage:

- a. Langdon, died in 1863.
- b. Henry Armstead, died in 1863.

c. James Jackson, born July 28, 1845. He married Mary Elizabeth Jarrett on May 20, 1866. Mary Elizabeth was born on October 11, 1848 and died May 7, 1938. James Jackson died on October 8, 1882. There were eight children to this marriage. Their fourth child was Augustus Octavios Bacon, born April 4, 1873; died in 1942 in Toccoa, Georgia. He was married to Elizabeth Jarrett. One of their children, a Augustus Octavious Bacon Turnbull, Jr., son, born on April 28, 1912; married December 26, 1935 to Isabella Graves Turner. They also had a named Augustus O. B. Turnbull III, born son March 7, 1940; Married to Marjorie Hayes Reitz on November 26, 1965. He became Provo (Vice President of Florida State University in Tallahassee, Florida. He died in 1992.

- d. Anna, married James Gilland.
- e. John.

JAMES THOODORE TURNBULL, (Medical Doctor), son of John and Jane. Born in Abbeville District, South Carolina on July 11, 1811. He graduated from Medical College of South Carolina in Charleston, South Carolina in March 1834. He in Leon County, Florida soon after he graduated and entered upon practice of his profession. He married Caroline Andrew Parish February 5, 1835 and lived in a home on the roadside just below old Concord Church, four miles south of Miccosukee, Leon County, Florida. Soon after they moved to Monticello, Florida and lived on Jefferson Street, of the Episcopal just south Church, where their first son Samuel was born on February 2, 1837. From here they moved to the then Parish home at Live Oak Grove, now known ass the McLeod Place. In 1852 they moved with their family, mostly boys, to Oxford, Georgia that they might have the advantages of Emory College. Leaving their oldest sons, Samuel and Richard, in College, they returned to Florida and lived for a while at a country place in Jefferson County - Lodamont - from where they moved to Sunrise, six miles south of Monticello, Florida where they built their permanent home.

Doctor Turnbulls wife was Caroline Parish, daughter of Colonel Richard Parish and Dorothy McGee Major. Caroline was born in Wilmington, North Carolina in 1817. Colonel Parish and his wife Dorothy moved to Florida permanently in 1827. Colonel Parish made several trips to Florida as early 1820 and was interested in business as in Tallahassee, Florida with his son-in-law Miles Blake. The firms name was Parish and Blake. They settled on Miccosukee Lake and called their home "Live Oak Grove" and bought all of the land on the Lake from "The Bluff" to within one mile of Lloyd Station. Colonel Parish is buried in the old Parish Cemetery on the Mcleod Farm in Jefferson County, Florida. His grave stone reads; "Sacred to the memory of Colonel Richard Parish born in the County of New Hanover, North Carolina, A. D. 1774 and died at his plantation near Miccosukee Lake 18th February 1838. Colonel Parish was among the earliest pioneers and settlers in this section of Florida and esteemed by all who knew him".

Doctor Turnbulls home on Sunrise Plantation is a two story frame home with four large chimneys, There are two fire places to each chimney. The home is still standing (1993), two of the chimneys have fallen and the house itself is showing the ravages of time. The name "Sunrise Plantation" was given to it by Caroline and Doctor Turnbull. There were over eleven hundred acres in the plantation.

Doctor Turnbull possessed a scientific mind. From the records of the Medical College of South Carolina; "Doctor Turnbulls Preceptor was Doctor Tennent of Abbeville and the subject of his thesis was: Billious Remmettent Fever of Middle Florida". Much of Doctor Turnbulls time was engaged in effecting cures by applying certain remedies. He was the first Physician to use quinine to kill malaria germs. He practiced medicine throughout Jefferson County, Florida from the Georgia State Line to Saint Marks, Florida near the Gulf of Mexico. His only means of travel was by horseback. He kept his saddle bags filled with medicines since no medicines were available along his route. Doctor Turnbulls health started to fail at an early age and he died in 1858 at 47 years old. Both Doctor Turnbull and his wife Caroline (died August 10, 1879) are buried in the family cemetery on Sunrise Plantation along with her sister Lydia and two of daughters; Emma Turnbull Reed and Caroline Turnbull their Smith. Sometime later Sunrise Plantation sold. The was cemetery was run down and Tom Turnbull in the early 1990s got a few of the Turnbulls together , and with his and their financial help, restored the graves and had the cemetery properly fenced. Doctor Turnbull and Caroline had twelve children:

- 1. Emma, born in 1835, married to Richard Reed. They lived in Thomasville, Georgia. Their child status is unknown. Emma is buried on Sunrise Plantation.

- 3. Richard, born January 7, 1839, in Jefferson County, Florida, and died July 15, 1906. He married Margaret Bellamy. There were ten children to this marriage:

  - b. William, married Mary Dillworth.
  - c. Ida, married Eugene Sloan. After Idas death Eugene Sloan married Virginia Turnbull the daughter of Samuel Turnbull.
  - d. Elizabeth Brooks.
  - married Louise Foster; lived in e. Richard J., Austin, Texas.
  - f. Margaret, married Wayland Yarbrough.

  - g. Emmila, married William Carroll. h. Theodore Tiffany, born July Tiffany, born July 7, 13, 1944. Married Pearl 1881; died January Whetstone (adopted name), born November 2, 1888; died October 25, 1949.
  - i. Thompson Lamar, died young.
  - j. Lucien, died young.
- 4. Junius, born in 1840; married to Willa Bellamy; they had eight children:
  - Simpkins, Margaret, Elizabeth, Junius, John, Mina (married to Milton Anderson of Monticello, Florida) and William.
- 5. Theodore, born in 1842; married Mary Simpson; lived in Miccosukee, Florida. They had three children: Emma who died young; Rosa, and Corrine who married William E. Yarbrough.
- 6. Julia, born in 1844; married to Smith Simpkins.
- Caroline, born in 1846; married Carraway Smith. 7. They had three children: Emma, Carraway who married Sarah Bellamy, and Clarence.
- 8. Ellen born in 1847
- 9. John E. born about 1849; married Juliet Turner. They had six children:
  - a. Vines, married Carrie Lee Daig.
  - b. Carrie, died young.
  - c. Jane, died young.
  - d. Henry P., married Irene Ashton.
  - e. Alpheus, born in 1885; married Marie LePage.
  - f. Juliet, died young.
- 10.Emmila, married Richard Parkhill.
- 11.Decimus Septimus, died in infancy.

12.Alexander Noble, died in infancy.

SAMUEL TURNBULL was born in Jefferson County, Florida on February 2, 1837. He graduated from Emory University near Atlanta, Georgia. His whole life after graduation was spent as a farmer (then called planters) in Jefferson County Florida. Samuel was married twice; (1) to Rosa Williams who died one year after their marriage during childbirth (the child lived and became a medical doctor). (2) To Virginia Finlayson in November 1865. Virginia Finlayson was the daughter of John Finlayson and Florence Shehee. Samuel died

August 24, 1897 and Virginia died in 1913. Both are buried in Monticello, Florida. Their children:

(By Samuels first marriage)

 Theodore, Medical Doctor, married Jane Denham. There were four children to this marriage:

- a. James Denham, died young.
- b. Samuel J., married Helen Chandler, they had three children: Helen, Elizabeth and Samuel J. Barton P., married Dorothy Gostenhoffer, they had three children: Margaret, Jane and Dorothy.

c. Jessie Lloyd, died unmarried in 1941.

(By Samuels second marriage):

- Virginia Finlayson, married to Eugene Sloan. Eugene Sloan was married twice; first to Ida Turnbull, daughter of Richard Turnbull and Margaret Bellamy; they had three children; Richard, Robert and Sarah. There were two children to the marriage of Virginia Eugene Sloan; Mary Bailey, a Medical Doctoor and unmarried, and Theodore Turnbull, married to Elizabeth Williams (no children).
- 2. ALEXANDER NOBLE, whose lineage is pertinent to this transcript will be discussed in the next paragraph.
- 3. Richard Randolph, married to Carrie Belle Tucker, are buried in Jacksonville, Florida. They had three children:
  - a. Elise, married to Clarence Stokes.
  - b. Joel Ucker, married to Elizabeth Manning.
  - c. Virginia, married (1) to Samuel Banta Hilliard; (2) to Phillip Howe; one child (Virginia) to the first marriage.
- 4. Mary.
- 5. Samuel Parish, married Willa Bell Matthews of Moultrie Georgia, both are buried in Moultrie. There were several that died in infancy. Two daughters lived;
  - a. Mildred Matthews, born August 28, 1915; married William Gatewood Workman, born May 29, 1909, son of James Workman and Martha Reaves Boykin; they had two children; William Gatewood and Eleanor Turnbull.
  - b. Eleanor Shaw, born August 5, 1921; married Eugene Cruiser Stryker, was born March 10, 1919, was the son of Jere Van Deventer and Edna Jane Cruiser. Eleanor and Eugene had five children: Patrecia Jane, Samuel Turnbull, Thomas Eugene, Margaret Elizabeth and Jere Vandeventer.
- 6. Daniel Finlayson, After retiring from the Bell Telephone Company he married Janet Parkhill and lived in Sarasota, Florida the rest of his life.
- 7. Branch, died young.
- 8. John, died young.
- 9. Thomas, died young.

ALEXANDER NOBLE TURNBULL was born in Monticello, Florida on March 15, 1871. He was the second son of Samuel Turnbull and could not settle on any one vocation. He was hard hit in two depressions, seems that his most successful vocation was farming. On June 24, 1901 he married Christina Oakley in Monticello, Florida. In November of 1908 they with their then three children moved to Prescott, Arizona where Alex entered the general merchantile business with a partner named Thomas Bottoms. Arizona was then a Territory. In 1911 the family became homesick for Florida, liquidated the business, and with the fourth child, returned to live on a plantation six miles east of Monticello, Florida called Silver Lake Plantation, named after a large lake bordering the southeast corner of the plantation. In 1915 the family, with two additional children making a total of six, moved into town where Alexander called Monticello, Florida his home until he died in 1933.

Christina Oakley was born on December 25 (Christmas Day), 1877. She was the daughter of Daniel Lorilaird Oakley and Cammilla Mills.

Daniel Oakley was born in New York City on February 8 1821. He was the youngest of nine boys. Four of the boys becoming ministers. All were born of a wealthy family. They were descendents of the "Earl of Cadogen". When time came for Daniel to go to College he flipped a coin to see if he would go to Princeton University or go to sea, the sea won. In 1849 Daniel joined the gold rush to California by way of the Isthmus of Panama. He was one of the lucky ones, he found gold and became wealthy. Come easy, go easy, and it was soon gone. Back to sea he went after his luck ran out in California. His sea travels took him around the world three times and it is claimed that he aquired and ran through three fortunes. On his last voyage he fell and broke his hip and this he was ubable to overcome. He used a cane the rest of his life.

In 1860 Daniel Oakley met a Mr. Bernard, a merchant from Monticello, Florida, who was in New York City to buy stock for his store. Mr. Bernard sggested to Daniel that since he was convalescing and having such a hard time recovering from his injury why didn't he try Monticello since it had sunshine most of the time, good people, good food, good fishing and many other inducements. This sounded so good that Daniel took him up on it and headed out to Florida and Monticello.

Soon after arriving in Monticello, Daniel Oakley met Camilla Mills and fell in love with her. She was born in Quincy, Florida July 18, 1840, was nineteen years his junior.

On April 25, 1861 they were married and with the possible exception of a trip or trips to Jacksonville, Florida 150 miles away, Daniel never left Monticello until he died November 14, 1900. Camilla died three months after Daniel on February 22, 1901. Daniels main support from the time he landed in Monticello until his death was money he brought namely; with the exception of several jobs, with him in the tax while, worked for a while Sheriff for a collectors office and helped his wife run the Saint Elmo Hotel. He had numerous friends who loved him for his kind and generous disposition. Besides Christina there were five other children: Martha Dillworth, Catherine Fredrica, Mary Camilla, Clifford B. and Waller Taylor.

Alexander Noble Turnbull died on July 18, 1933 and his wife Christina Oakley died in Tallahassee, Florida on February 24, 1972. Christina was ninety four years old when she died and had resided in Tallahassee, Florida the last thirty years but she never lost her love or interest in Monticello, Florida where she was born on that Christmas day in 1877.

Following is an editorial from the Monticello News, Monticello, Florida which appeared shortly after the death of Alexander Noble Turnbull which briefly characterizes his life especially as a family man:

"Mr. Turnbull devoted his entire life since marriage to the comfort and care of his family giving them to the limit of his ability those things make for that happiness and contentment. As a husband his was forever faithful, tender, loving, thoughtful, cherishing until death the wife of his youth. As a father he was a good provider, his childrens best friend until his passing, and setting for them an example they needs must follow; ever ready to give them his all. It was his greatest happiness in life to gather them in his home, and their greatest pleasure to be there enjoying his unstinted hospitality and the genial warmth, companionship and love of Daddy and Mother, sisters and brothers. He often said: to help my children is my deepest pleasure. His friends were numbered by his acquaint-ances. His cheerfulness of disposition, his unfailing sense of humor, his sincere sympathy when some fellow man was in distress or trouble, and his strict adherence to the Golden Rule, Do under others as you would have them do unto you, made him loved by all with whom he came in contact. His honesty and integrity were unimpeachable. A firm believer a in Almighty God, Christian of great faith, of beautiful ideals, he leaves a heartbroken family consoled in his passing only by the knowledge that to emulate his example will insure meeting him in Heaven, where he is today"

Alexander Noble and Christina Oakley Turnbull are buried in the cemetery in Monticello, Florida side by side.

Lt. in 1942, left the of Service in 1942 with the rank of Major. Spent thirty years with the State Road Department of Florida, the last five and one-half years being Chief Engineer. Was Chief Engineer on the construction of the original Florida Turnpike from Miami to Ft Pierce. Was Engineer-Director for the Florida Road Builders Association. Presently (1993) Chief Engineer for McKenzie Tank lines. Married Alice Marie Callegari, born in Cottonprt,-Louisiana on July 22, 1909, d 1989. Alice is buried in Monticello, Florida. 1909, died January 25,

Thomas Bottoms Grandfather (Samuel Turnbull) and Margaret Scotts Grandfather (Richard Turnbull) were brothers. Tom and Margaret Scott adopted two children; Richard Randolph and Margaret Scott. Tom was born in Thomasville, Georgia but spent most of his early life in Monticello, Florida. Most of his adult life has been spent in Winter Haven, Florida where he was engaged in the Citrus Fruit Business. Presently Tom has retired and lives in Tallahassee, Florida.


